PHOTOGRAPHER PERMIT

CNA Championship has booked a professional photographer who is under contract for all 'in ring' photos of the main ring, outside rings. Family or Friends may take photos/videos of their rider/handler from the outer perimeter of any show ring, those personal photographs may be posted on Facebook, Messenger, Emails, etc. However, the photographs taken by family or friends are not permitted to be sold either online or privately. In addition, professional photographers, not under contract with CNA, are not permitted to take nor sell photos/videos at anytime during the CNA Championship show. No additional permits will be given out to anyone other than the contracted photographer.

Farrier & Veterinarian Permit

No other Farrier or Veterinarian will be permitted to work on the grounds other than the official Farrier and official Show Veterinarian (on call) without registering with the Canadian National Arabian Championship show. Exhibitors wishing to use a Farrier or Veterinarian other than the official farrier or veterinarian must apply at the Show Office and pay a fee of \$100.00 before they can officially work on the grounds at any time during the Canada's National Arabian Championship show.

Leadline Exhibition - Class 600

STATEMENT OF PRINCIPAL

The Equestrian Canada Federation (EC), the national federation of Canada, supports adherence to humane treatment of horses in all competitions under its jurisdiction. The EC is committed to:

- Upholding the welfare of horses, regardless of value, as a primary consideration in all activities.
- Requiring that horses be treated with kindness, respect and the compassion that they deserve, and that they never be subjected to mistreatment.
- Ensuring that owners, trainers, exhibitors and their agents use responsible care in the handling, treatment and transportation of their horses as well as horses placed in their care for any purpose.
- Providing for the continuous well being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, sanitation, and safety as a matter of standard operating procedure.
- Continuing to support scientific studies on equine health and welfare.
- Increasing education in training and horsemanship practices.
- Requiring owners, trainers and exhibitors to know and follow their sanctioning organization's rules and to work within industry regulations in all equestrian competitions.
- Reviewing, revising, and developing competition rules and regulations that protect the welfare of horses.

The standard by which conduct or treatment will be measured is that which a reasonable person, informed and experienced in generally accepted equine training and exhibiting procedures, would determine to be cruel, abusive nor inhumane.

The CNA Championship (Silver) competitions is sanctioned competition members of Equestrian Canada %House of Sport, 2451 Riverside Drive, Ottawa, ON K21H 7X7 and governed by the Rules of EC

THE RULE BOOK

Exhibitors, Judges, and Show Officials are responsible for knowledge of the Rules. Both a complete knowledge of and compliance with the rules are essential, and all participants must be fully cognizant of all rules as well as class specifications in the division in which they compete. Full details of Horse Show operation - EC (including FEI) rules - list of recognized Judges - **other vital information is in the RULE BOOK** copyright for exclusive use of recognized shows. See current EC Rules and Amendments. Every individual is eligible to count points won at recognized EC Shows for Annual and Provincial Championship Awards. The current EC Rules and Amendments are presently in effect and have been used to compile the Rules and Regulations for this prize list. Passports are NOT required in a recognized "Breed" competition.

Amateur status is included in the License but must check it on application for it to show up on the Sport horse License

Membership to EC is now called "Sport License".

****Please refer to the EC Rules on Membership*** Memberships are NOT sold at the Show Office*
*Regional & National Breed Shows require an EC Silver Sport License EC Article B1302.2**

SPORT LICENSE (memberships) All exhibitors, owners, trainers, riders, drivers, handlers, coaches from the Canada or USA must hold an Equine Canada License to attend in any Canadian horse show. For active USEF Memberships a free Sport License will be issued once you complete the Equine Canada Safe Sport courses. See below

USEF Members must now register with EC starting with [Welcome to Equestrian Canada](#) USEF Exhibitors must have a current USEF Membership and they will need to create a profile, including their USA address, with Equine Canada via the [MyEc Portal](#). The Equine Canada system will validate the USEF membership with no payment. Once the Safe Sport courses are completed - it will be good for 3 years.

EC COACH STATUS 2024

EC Coach Status Section A, General Regulations, Article 102, Safe Sport Environments

Effective July 1, 2023, Canadian residents coaching athletes at EC-sanctioned events must meet minimum EC Coach Status requirements:

1. Temporary Coach Status is now to be purchased directly from EC via the MyEC Portal.
2. Competitions must ensure all coaches named on entry hold either EC Licensed Coach Status OR have purchased Temporary Coach Status.
3. Temporary Coach status can be validated via the Competition Support Portal of the event.
4. This means no more paper forms to be collected from the coach on-site.
5. Temporary Coach Status will be available until December 31, 2025; after coaches at all EC-sanctioned events must meet Licensed Coach Status.

PERSON(S) RESPONSIBLE to be signed on all entry forms

The Person(s) responsible (PR) for a horse must be an adult who has, or shares responsibility for the care, training, custody, and performance of the horse and who has official responsibility for that horse under EC Rules. The PR is liable under the penalty provisions of the applicable EC Rules for any rule violations. Every entry form for an EC sanctioned competition must identify the PR and be signed by the PR. The Person(s) responsible is ultimately responsible for the condition, fitness and management of the horse and is alone responsible for any act performed by himself/herself or by any other person with authorized access to the horse in the stables, elsewhere on the grounds, or while the horse is being ridden, driven or exercised.

A: For adult entries into EC sanctioned competitions the PR shall be either the trainer, the owner of the horse of the competitor who rides or drives the horse during the EC sanctioned competition. *Section A Page 101*

B: For Junior entries into EC sanctioned competitions the Junior competitor cannot be the PR. For Junior entries the PR may be either the trainer, the owner of the horse, or a parent/guardian of the Junior Competitor EC Article A801

Equine Canada Ruling on Vaccinations:

ARTICLE A602 PRIZE LISTS – MANDATORY INFORMATION “All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations.”

ARTICLE A802 ENTRY FORMS (7.) the following statement, must be signed by the person(s) responsible: “I hereby certify that every horse listed on this entry form has met the requirements of Article A519, Vaccinations”.

A Vaccination Declaration must be completed and sent in with the entry for every horse!



KNOW YOUR VACCINATION REQUIREMENTS

EQUINE INFLUENZA & HERPES VACCINATIONS AT EC SANCTIONED COMPETITIONS



WHO?

- All equines entering in Equestrian Canada sanctioned competitions as of 2020



WHAT?

- Equine Influenza Vaccination
- Equine Herpes Virus 1 & 4 Vaccination



WHEN?

- Primary vaccinations must be given in accordance with manufacturer recommendations
- Boosters vaccinations must be provided annually (every 12 months) thereafter
- Vaccination must be administered within 6 months (plus 21 days) of ARRIVING at the competition
- BUT NOT within 7 days (1 week before) of arrival to the competition
- MAKE A PLAN WITH YOUR VET!



HOW?

- EC will require that all responsible persons must declare compliance with vaccination requirements on their entry form
- Individual competitions can require proof of vaccination
- Proof of vaccination can be in the form of a veterinarian's receipt or invoice
- If you administer your own vaccinations, you must provide a receipt, batch number, and date of administration
- ALWAYS CARRY YOUR PROOF OF VACCINATION WITH YOU!

General Rules

1. All entries are accepted with the understanding that the Equestrian Canada Federation and the CNA Championship Horse Show Commission, their officers, contracts or volunteers or any of its affiliates, will not be held responsible for any loss, damage or injury to any exhibitor, his or her agent or employee, or to any horse or any article of any kind. The exhibitor will be responsible for any loss, damage or injury, to any person, animal or property occasioned by him, his agents or employees, or by any animal owned or exhibited by him and shall indemnify all parties listed above against any and all loss, damages, or liability thus occasioned, including but not limited to any and all legal costs, including attorney fees, which may be incurred as a result thereof. Submitting of any entry form to the Entry Secretary shall constitute an acceptance by each person signing same of the provisions herein set forth.
2. Upon any act of discourtesy or disobedience to **any** official or volunteer of the CNA Championship Horse Show on the part of any owner, groom, rider, driver, or handler may result in the immediate removal from the show of said person, at the discretion of the Show Commission and the owner will forfeit their entry fees. Such action will be reported to EC and or disciplinary action. Official protests (\$100 cash fee) will be filed as per the EC Rule Book A1206.
3. The CNA Commission reserves the power to remove any person or horse from the show without being liable for compensation.
4. The CNA Commission reserves the right to add to, amend, or decide any point not covered by the rules and to correct any error or make necessary alterations in the show prize list and the show program.
5. The CNA Show Commission reserves the right to cancel any class with less than three (3) horses entered.
6. Patterns & Orders of Go will be posted 24 hours prior to classes.
7. Potentially large classes, (18 or more) , may be split by the CNA Commission into a Section A & Section B with a Final section. This will be announced prior to the start of the show with 6 from each section going forward to the final section. Horses moving forward will receive a finalist ribbon.
8. Scoring System is MOS – Majority of Opinion System – See Current EC Handbook.
This system will be used for all CNA Championship Classes including Halter Classes.
Specialty Classes – Dressage, Sport Horse In Hand & Under Saddle, Working Western, WHOF - will be scored using a one judge system.
9. No horse shall remain on the grounds if it is not entered in the CNA Show unless written permission is granted by Show Commission- *exception Mare with foals at side* **Every horse entered in this show MUST have a stall.**
10. Stallions are permitted in Junior Exhibitor Performance Classes. Stallions are NOT permitted in Junior Showmanship, Walk/Trot/Jog or Lead Line
11. Dressage classes & Sport Horse In-Hand classes will receive awards after EACH class.
12. Sport Horse In Hand Classes will use Pattern “A”, Triangle. (Refer to EC Article B2405.1/USEF 1649E1.1)
Sport Horse In Hand will be split to Dressage Type and Hunter Type for the CNA Championship Show.
13. Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book. (EC Article A602) Lead Line is a nonrated EC class.
14. **Stall drapes or stall roof material must be nonflammable material only. Proof of flame-retardant material may be asked for. Please have certification of flame-retardant material on hand.**
**** Lights will be off in the stabling areas at night to allow for horses to rest.****
15. **NO gas, electric or propane heaters, tanks or hot plates are allowed in the stalls or stalling area at any time!**
16. Age of Junior or Youth exhibitors for this show is 18 years as of December 1, 2023 Unless there is an age listed in the title
JTR & JOTR classes are 18 years & Under. ADULT --- AATR & AAOTR classes are 19 years & Over
Minors who do not have a valid driver license in their province or state of residency will not be permitted to operate any motorized vehicle including but not limited to golf carts, scooters or utility vehicles!
17. **It is the responsibility of every exhibitor to secure their personal property on the own. SECURITY is onsite but limited. CNAC is not responsible for loss or damage.**
18. Hors Concur will not be considered at the Canada’s National Arabian Championship.
19. Substitution of any horse will be handled on an individual basis and approved by the Show Commission.
20. **Unrelated Owners In Owner Classes** - For the purpose of showing in Junior Owner and Amateur Owner classes, two non-related owners will now be able to co-own a horse and show in owner classes provided that :**Refer to Equestrian Canada rules for more information!**
21. ****Select Class Rules for CNAC****
Exhibitors may NOT enter a Select Class at CNAC if you have placed as a Reserve Champion or a Champion in any class of that division at any previous Canada’s National Arabian Championship show or if you are already determined not select by the levelling rules

NOTES:

1. Full payment MUST accompany the entry by credit card + 5%, cheque or e-transfer to be considered complete and acceptable. Credit Card +5% must complete the form and process with no declining! A \$75 charge will be given to the declined entry fee!
2. Entries emailed or post marked on or prior to June 15, 2024 will incur no post entry penalty.
3. Entries emailed or post marked dated between June 16 – July 30, 2024 can add a new horse with a \$500 fee plus regular fees.
4. Any horse already entered when adding a class will add at \$180.00 plus \$75 late fee plus GST = \$267.75.
5. NO entries will be accepted after Midnight, August 5, 2024. However, classes may be added at \$180 plus \$75 late fee plus GST = \$267.75.
6. All entries emailed or mailed wishing to stable together MUST do so with a completed stabling form listing all owners for all horses.
7. Payments: Credit Card plus a convenience of 5%, E-transfer, or Cheque GST # 76066 0811 RT0001
8. NSF Fee Cheques or Declined Card Fees will be charged \$75.00.
9. **Classes exceeding 18 entries MAY be split by the CNAC Commission into an A and a B by random draw with a corresponding Final class.**
10. **Decisions on adding sections OR removing sections will be posted prior to the start of the show. Classes already split in the schedule may have sections eliminated if not enough entries to warrant a split.**
11. **Moving forward to the Final class from each section will be 6 horses. Horses moving forward will receive a finalist ribbon.**

Entry Form must be done with one horse and needs to include all:

- a. Signatures (Back page of entry form must have all signatures indicated on the top and the bottom of that page) (No Minors),
- b. Horse papers
- c. Owner classes must have the OWNER name that is on the horse papers.
- d. EC Sport Horse Silver Membership for all owners, riders, handlers - and USEF Memberships "New" (see EC Rules).
- e. Coach Name or Self Declared must be put on the entry form and signature on the back of the entry form.
- f. Stabling Form.
- g. Vaccination Declaration.
- h. Payment.
- i. Entries are not considered on time and not completed without all areas completed with all information supplies – including PAYMENT!

E-TRANSFER

E-transfers is accepted.

- a) The **E-transfer** must be completed prior to mailing or emailing the entry on this Championship Show.
- b) Once the **E-transfer** is confirmed, make a copy and attach it to the entry form!
This will be confirmation by payment to the Treasurer.
- c) If this is not completed, copied & mailed or copied & emailed with the entry, it will be considered a late entry. Fees may be doubled.

3. CANCELLATION OF ENTRY

1. Exhibitors cancelling entries after the closing date of June 15, 2024 shall forfeit ALL fees unless accompanied with a valid Veterinarian Certificate stating the Owner name, Horse Name and reason for Vet Out!
2. Veterinarian Certificate (Vet Outs) will only be accepted until midnight, Monday August 5, 2024.
3. After midnight – August 5, 2024, NO monies will be refunded.
4. Vet Out refunds will be mailed issued by cheque to registered Owner after the completion of the show.
5. **Refund:**
 - a. Stall fee - \$349.00 + (5% GST) \$17.45 = \$366.45
 - b. **NO stalls** are refunded at any time.
 - c. **NO Office** fees will be refunded at any time - \$80.00 plus \$4.00 GST = \$84.00.
 - d. **A non-refund of \$75.00 plus \$3.75 = \$78.75 will be held back on all Vet Outs.**
6. All horses must be entered in the proper classes and be entered in the name of their bonafide owner or lessee as per the registration papers. Copy of a registered lease agreement must accompany entries for leased horse.
7. EC Silver Sport License or USEF with EC Safe Sport Courses are required for Canada’s National Arabian Championship classes.
8. Acknowledgements will be sent out by EMAIL to all trainers and/or owners. Make sure that an email destination is printed on your entry form.
9. ELIGIBILITY All horses entered must be registered with the Canadian Arabian Horse Registry; AHA Arabian Registry; the AHA Half-Arabian/Anglo-Arabian Registry; or the Canadian Arabian, Half-Arabian/Anglo-Arabian Registry.
10. Competitors are allowed to enter only the achievement level they are qualified for. Cross entry between achievement level & AOTR is ok.
11. Age Splits for Junior Classes will be 13years & Under and 14-18years.
12. **Performance Halter:** Refer to Rules of EC Section B Chapters 13, 14 & 15
Classes will be Arabian & HA/AA and MUST be Stallion, Mares or Geldings that are 3 years and over in age.
A horse must enter a **performance class** at this show in order to be in the **performance halter class**.
Canadian National Arabian Championship offers Stallions-AATR and Mares & Gelding classes.
13. **NEW:** In-Hand Trail is for horses 3years of age or younger. NO cross entry into any under saddle class is allowed.

3. EVERY Horse entered in this show or on the grounds **MUST** have a stall. There will be no exceptions.
4. Stabling **includes** unlimited bulk shavings.

5. **STABLING FORM** *Please complete the stabling form*
All groups stabling needs to be on ONE form. If unable to be on one form make sure there is a “common” stabling name. Those wishing to stable together need to send that form with all entries in the same envelope.

Exception: if unable to get the entry form to the person sending the stabling form in then be sure to put the common GROUP Name on your stabling form otherwise we cannot guarantee you will be stabled with that group.

6. Horses must be entered in CNA Championship at the time the stabling request is made. Indicate the exact number of box stalls and tack rooms. If the show is overbooked, Show Commission reserves the right to use tack rooms for horse stalls.
7. Exhibitors WILL NOT move from their assigned stalls without permission from the Stabling Manager. Violation of this rule could result in the exhibitor & their horses being excused from the show grounds for the balance of the show without refund entry fees
8. Absolutely NO blocking of aisles. The barns are a “Public Area” and easy, clear and safe access must be provided. It is mandatory that stabling areas are kept clean.

9. FOR SAFETY REASONS NO PERSON IS ALLOWED TO TIE A HORSE TO THE EXTERIOR OF ANY STALL OR CROSS-TIE ANY HORSE IN THE ALLEY-WAY FOR ANY REASON. THIS MEANS NO GROOMING, TACKING UP, FARRIER WORK ETC AT ANY TIME DAY OR NIGHT. PERSON RESPONSIBLE WILL ASSUME ALL RISKS AND LIABILITIES. NO EXCEPTIONS
This will definitely be enforced at this CNA Championship show.

10. **BEDDING** ***Shavings are included in the stabling fee, however due to the short supply of shavings, exhibitors are asked to limit the amount used and keep it at a minimum. NO shavings will be allowed in the aisle ways of the barns/tents.*
*** Important: be respectful of the quantity of shavings that you use in each horse stall.***
11. Bobcats or units with a Front End Loader *will not* be allowed on the grounds for use in the bedding or cleaning of any stalls unless pre-approved by the Stabling Manager. **Misuse of Shavings will NOT be tolerated.**

"STALLS MUST BE VACATED BY 8:00 am MONDAY, AUGUST 19, 2024"

Ensure that all garbage, string, twine, nails etc. is removed from your area in the barns/tents. Any damages to stalls, walls, doors or any part of the “facility” by any exhibitor, trainer or owner - they will bear the cost to repair.

CNA STABLING REMINDERS

1. **STABLING FORM** needs to be completed, and sent with entry form & payment.
2. Group stabling will need to be sent in the same envelope and if not, Stabling Manager cannot guarantee all are together.
3. All Stabling **MUST** be mailed by June 5, 2024 with the entry forms to guarantee and stalls or tack rooms.

CNA In Hand/Breeding Classes - In the Ring Class Procedure – Judging begins when the first horse enters the ring and its movement is being evaluated and scored. The horse shall enter at a trot. In order to lessen stress on In Hand horses, grooms/owners etc. will be requested to leave the hitching ring prior to the entry of each halter class. CNA Championship In Hand/Breeding classes will use a Comparative scoring system

HALTER - One specified person assisting with entrance of in-hand horses into the ring will be allowed to use only the same length whip and appendages as are currently allowed for the individual handling the horse. Whips are to be no longer than 6' including snapper/lash/appendage. Small appendages (no more than 12 inches in length) of ribbon, plastic, etc. are permitted. The designated person will not hit or use any other objects, such as trash cans, walls, etc., to make any noise. In addition, effective immediately, the use of plastic or paper bags of any type or size is prohibited in assisting with entrance(s) into the arena ALL In hand horses are required to enter their halter class in the assigned, posted order of oldest to youngest --- Including Sport Horse In-Hand classes

Biosecurity guidelines at a Horse Show

Make sure your horse is healthy, up to date on vaccinations, and fit for travel and competition. This starts at home, long before the show. Clean and disinfect the stall(s) your horse will use at the show. Leftover manure, shavings, and dirty walls are potential hazards. Remove all remains of bedding, and then let soap and water work on the walls. For added measure, you can rinse with a 1:15 ratio of bleach to water. Take responsibility for your horse – be his advocate. It's perfectly fine to ask someone not to touch your horse. Respect your fellow competitors and owners as well by not smooching or scratching their horses. Monitor your horse's temperature. Most horses will appear normal with a fever long before the fever makes them appear ill. Twice daily at shows is a good idea, and continue the twice daily for a bit after a show and travel. Don't share. I know this is contrary to every Sesame Street episode, but diseases are contagious! If you have extra things in your trailer that you could lend out without needing it back, you may be OK. But it's a hard pass on sharing brushes, some skin infections are contagious via brushes. Hoses that are shared among horses can also be a source of infection, so bring your own. your horse is the most social creature on the planet, it's going to be a rude awakening when you explain to him that nose-to-nose contact is off the menu. It's fine to get him a stuffed animal instead. Situate your horse so he can still see other horses, but maybe at a distance. Tack stalls are great to put between horse stalls at shows. If you are concerned about biosecurity at a show, talk to your veterinarian and the Show Management.

Golf Cart Rental

Barn Calls & Gate Holds

Barn calls are a courtesy.

Exhibitors must ascertain when and where classes are being judged. Every effort will be made to advise the exhibitor of any changes in the Tentative Schedule. Check in at the show office to be keep up on any changes.

Due to unforeseeable problems with any mechanical device, the public address system and paddock calls over that system must be considered a courtesy. It is the responsibility of the exhibitor to be sure that their horse is at the gate at the prescribed time. Every effort will be made to maintain a working public address system to carry class calls, however no protest will be upheld, nor will any section or class be changed on the basis of the public address system malfunctions.

Exhibitors are responsible for reporting **all entries** to the **Paddock Master** before each respective class is called for showing **and** must enter the ring promptly when called. It is important that you listen carefully and report immediately to the paddock when your class is called.

Two Minute Gate: In collective classes, the gate will close **two (2) minutes** after the first horse enters the ring or in large classes taking more than two minutes the gate will be closed at the completion of the final horse in a continuous string of horses entering the ring – After the gate is closed no entry will be allowed in unless approved by the Judge or Steward. **No exceptions.** EC B1305.8.

In single event classes, (i.e. reining) the gate will close within **one (1) minute** of that individual rider being called to the ring in the Order of Go.

No entry shall go out of order unless approved by the Show Office.

**GATE HOLD requests need to be registered at the Show Office no later than one FULL session before the class is held.
NO Gate holds will be granted if it is a class conflict with other ring(s)**

RING PROCEDURES

- Grooms, attendants and headers are to appear in the ring neat, clean & suitably attired, in the opinion of the Show Commission i.e. clean, unmarked smock. If required at any time.
- No person other than the officials, steward, attendants on duty, and the judge(s) of the class may enter the show ring without permission from the call judge.
- Any exhibitor using the wrong number or having no number **may** be excused or disqualified from the class at the discretion of the call judge.
- CNA Championship will use the "in ring procedure" for all halter classes.
- Exhibitor small number card must be with the horse at any time that it leaves their stall and the large number on the back of the exhibitor - except: Dressage Test which can use the small numbers (EC rule)

STRESS

Horse shall not be punished unnecessarily or severely anywhere on show grounds.

Abuse will be dealt with under the EC rules.

Any horse entered in any class at a competition may, while on the competition grounds, be selected for equine medication control testing. (EC Article 602.5) By entering the show all owners agree to testing for their horse(s) if selected for one.

A Silver show testing fee charge of \$8.04 (includes GST) charged to all eligible horse will be made and is included on the entry form. *EC statement – Any horse entered in any class at a competition subject to the requirement to pay drug testing fees may, while on the competition grounds and on the recommendation of the chairman of the provincial Equine Medication Control Committee or the chairman's appointee, be selected for equine medication control testing.

All horses artificially, improperly or unfairly prepared or tampered with before coming into the show arena will be disqualified. The use of any substance to induce temporary heat will not be allowed.

If it is ascertained that an exhibitor has made, or caused to be made, any false statements in regards to any animal or article exhibited or if any exhibitor shall attempt to interfere with the judge in performance of his/her duties, they shall be excluded from competing or exhibiting.

EC Ruling: B1501.22

DRESSAGE riders are subject to Dressage rule E 4.0.3 Safety Headgear. APPROVED helmets must be worn by all riders competing in Fourth Level and below, Material and Equitation classes at EC Arabian breed Silver competitions. This rule applies whenever the dressage rider is mounted on the competition grounds or warming up for a test. Penalty for contravening 4.0.1 is elimination. At the tack check which follows the test, the steward may ask the rider to dismount so that the helmet may be inspected for the ASTM/SEI or BSI label.

Riders warming up and competing in all other Arabian divisions are NOT subject to this rule but are subject to the rules of their division or discipline, however helmets are encouraged in all other divisions. (Article 802.6). An approved helmet must be worn in any over fence class at these shows.

CNA Arabian & HA/AA Hunter Over Fences

Schedule: Classes 29-35 on Friday, August 9, 2024 - Judge: Jill Barton

Working Hunter Over Fences will have each class - a Section A, Section B and C Under Saddle.

Each horse will be given a numerical score that is **announced** following their completion of each round & **prior** to the next horse starting their course. Awards will be presented at the end of the last class.

BORDER CROSSING

- ✓ Regulations at border crossings do change periodically.
- ✓ Always check well in advance so that on arrival, you will have all the necessary certificates, forms and information available.
- ✓ There is no duty or sales tax on horses entering either the U.S.A. or Canada.
- ✓ Veterinarians are usually on duty from 8:00 a.m. to 4:00 p.m. from Monday to Friday. Check the border crossing for exact times as there could be a charge when crossing outside of these hours.
- ✓ You must call ahead at **least 24 hours** to make an appointment for border crossing with horses. Many crossings are **NOT** open on weekends or after hours for livestock traffic. Establish this information well ahead of arrival to avoid long delays.
- ✓ Border Crossing into and out of Canada require proof of U.S. Citizenship with a passport with raised seal. Check for crossing ports.
